## **FUNERAL COMMITTEE OF ILFORD ISLAMIC CENTRE**

### Rules and Regulations of the Funeral Committee

1. The aim of the funeral committee of ILFORD ISLAMIC CENTRE is to provide financial assistance to a member, his / her spouse and dependents in the event of a bereavement in the family
2. All Muslims are eligible for the membership of the funeral committee.
3. Membership of the funeral committee runs on a year by year basis.
4. Every member shall have to renew his/her membership within one month of the expiry date. Failure to renew membership results in a forfeit of his/her membership and right to claim benefits in the event of a bereavement.
5. Members who are abroad, shall be allowed a three month grace period for renewal of membership after due date.
6. By virtue of his/her membership, a member's spouse and children up to age of sixteen years (up to 18 years providing if he/she is in full time education) will be treated as members of the funeral committee.
7. After the death of a member, his/her widow/widower and children up to the age stated in paragraph 6 will remain members of the funeral committee providing the widow/widower pays the subscription and subsequent renewal fee.
8. In the event of a widow member, a remarriage option shall be open for her husband to become a member of funeral committee. If he fails to avail this option, his wife and his children shall remain members of funeral committee until the expiry date after which the membership will be withdrawn.
9. Member's children who reach the age of 18 years are eligible to apply for the membership in their own right by paying the annual fee.
10. Member's right to claim benefits shall not be prejudiced in the event of residing outside the UK.
11. A person under hospital treatment or who has a medical history of heart problems, cancer or is HIV positive shall not be eligible for membership of the funeral committee.
12. A person can take membership of the funeral committee up to the age of 55 years.

### **SUBSCRIPTION AND RENEWAL FEE.**

The enrolment fee for the funeral committee is £150.00 (One Hundred and Fifty Pounds)

The annual subscription fee for membership of the funeral committee shall be £ 100.00 (One Hundred Pounds) annually and shall not be refundable.

### **BENEFITS**

The amount of benefits payable in the event of death to a member, his wife or children shall is as follows.

- A. Member or his / her spouse ..... £ 3,000.00 (Three Thousand Pounds)
- B. Children up to age of 18 years..... £ 800.00 ( Eight Hundred Pounds)
- C. In the case of a 'disaster' where more than "two" members' death take place, a maximum £ 7,000.00. (Seven Thousand Pounds) will be paid.

*Note 1 - The minimum period for qualification of benefits will be one year after commencement of membership.*

*Note 2 - Families of the bereaved must make payment directly to the cemetery at the time of burial.*

*Note 3 - Payment from Ilford Islamic Centre will be made to the deceased's family within 7 days of the funeral.*

*Note 4 – In the event that Funeral Committee funds are depleted, the members will collectively make up any deficit.*
